Side Ancient City







Determination of Topics



Transport and Recycling


Collected waste is regularly transported to licensed recycling facilities and reintroduced into the economy.

Biodiversity

Barut B Suite deeply understands the importance of protecting biodiversity, being aware of the value of ecosystems and the environmental benefits they provide. Our goals include minimizing negative impacts on biodiversity, actively supporting and protecting ecosystems and endangered species. Our facility, operating in the Side region, takes various measures to protect the habitats of rare and protected plant and animal species in the region.



Sea Turtles

Caretta caretta Conservation Efforts

As Barut B Suite, we also host the nests of Caretta caretta sea turtles on our beach. In order to protect these nests, we share our sensitivity about the use of the beach with both our employees and our guests within the scope of the Project carried out by DEKAFOG.

Our teams working in coastal areas regularly receive periodic training on Caretta carettas and keep this information up to date. In addition, there are environmental awareness panels and information signs in specially protected sand lily areas throughout the facility to inform hotel guests.

Active Protection Activities

As Barut B Suite, we not only protect the vegetation and natural habitats in the regions where our hotels are located, but also actively contribute to the Sea Turtles Protection Project carried out in Manavgat.

This project is an important study carried out to protect the breeding grounds of sea turtles and ensure the sustainability of their generations. Within the scope of the project, monitoring of sea turtles' spawning grounds, taking protection measures and awareness-raising activities are carried out.


Innovative Afforestation Project

In its fifth year, Barut Hotels' We Care All Sustainability Awareness movement brings 5,000 seed balls together with the soil in the Muğla region. The seeds brought into nature on the occasion of Forest Week were planted in areas determined by e-cording and the General Directorate of Forestry at certain intervals between March and May 2024.

Women's Employment and Technology

Red pine and black pine seed balls are brought together with the soil through a detailed and dedicated process, from preparation to leaving them in the field and monitoring. Continuing its activities with the aim of supporting the local economy, creating income for women in rural areas and bringing the seed balls they prepare together with nature through partners, the social enterprise ecording has brought together 15 million seed balls with the soil since 2019.

In order to increase our positive impact within this wide network and create a sustainable impact, it is critical that our stakeholders understand our business principles and internalize these principles.


Environmental Performance






Our Strategies to Combat Climate Change


